La Vita COVID-19: Knowing that the situation is very fluid, and information presented May 1st may change in months, weeks, or even days, here are some La Vita-specific updates as of May 1st: **Face Coverings:** Effective May 1, face coverings are required in the County of San Diego for everyone not inside their own home/car, etc if you will be within 6 feet of any non-family unit member. This applies to all La Vita common areas including the stairwells and elevators.

Pool, Gym, and Amenity Room: These areas will remain closed until further notice. The Board will follow all recommendations set forth by the State of California and the County of San Diego when determining when and how the gym and pool can be reopened.

In addition – we are using this down-time to complete the removal of the plaster (which was utilized in error by a previous contractor) and applying fiberglass. This will allow for a longer life for the pool and spa interiors.

Lobby Renovation Completion is still on hold until the stay at home order is lifted.

HVAC inspections: The annual HVAC inspection is on hold until the stay at home order is lifted.

Window Washing: We will schedule window washing as soon as such non-essential work is approved.

Frequently Asked Questions

Will HOA dues, fees, or late charges be waived due to the pandemic?

Short answer is "no". The Association expenses have not changed due to the COVID-19 pandemic. All bills, utilities, and invoices must be paid and the Association relies on HOA dues to cover those expenses. Even though the pool and gym are currently closed, neither of those creates substantial reduction in expenses.

My neighbors continue to have gatherings in their homes. Is this okay?

Please keep in mind that the State of California and the County of San Diego recommend that your home is **only** for your family unit. Residents are reminded that having non-family unit gatherings in your home is neither acceptable nor responsible.

Per the County of San Diego: <u>"All public or private events or convenings that bring together more than one person in a single room or single indoor or outdoor space at the same time are prohibited. The order does not prohibit a gathering consisting only of members of a single family or household."</u>

Since the Little Italy dog park is closed can we utilize the Courtyard lawn?

Again, short answer is "no". With families at home many children are playing, rolling, and lying on the grass. Also other residents have been enjoying the lawn area for sunbathing. (Just remember to **always** cover your face!). We are noticing distinctive "brown spots" on the lawn, and have observed some residents and their pups lingering perhaps a bit too long in the Courtyard. As conveyed in the La Vita Rules and Regulations, the Courtyard is for entrance and egress from the complex with pets. Please help us by not allowing your pooch to relieve him/herself on the lawn. Thank you!

Dog Park News: LIA has received permission from the County to reopen the Little Italy Dog Park, but the County is requiring a staff member be on-site to manage visitors and enforce capacity, physical distancing and face coverings. The cost for this staff member to manage the space for 8-hours a day/7-days a week is \$1,100. That's 11 people donating \$100/week or 22 people donating \$50/week.
