**Safety Updates:** We want to thank all our street level owners for keeping their patio gates locked to help keep transients from entering. This helps to reduce trespassing onto patios and onto our property.

For those ground-floor units, SDPD suggests that you obtain a "Letter of Agency" and file it with the City of San Diego. This allows SDPD to act as your agent if anyone is trespassing on your patio or property. If you are interested in joining one of our advisory committees, please contact our Property Manager, Sabrina. We have recently documented the various committee charters to bring them up to Davis-Stirling Act standards (the special governing HOAs code in California). These charters provide guidance on the roles of committee members to the Association. We would love to see you at our monthly HOA meetings. They are held on the fourth Tuesday of each month in our lobby level meeting room.

La Vita Rules & Regulations: Do you have a copy of the newest R&Rs? They were updated in 2016 and mailed out to all homeowners. They are also available on the la Vita website, LaVitaHOA.org in the documents section.

Make sure you familiarize yourself with the R&Rs. If you have tenants, you are required to provide them with copies of the R&Rs, and also the CC&Rs documents.

## Frequently Asked Questions (FAQs) for Summer

#### What are some important things to know for summertime at la Vita?

**Smoking:** Smoking of <u>any kind</u> is strictly prohibited in all Common Areas of la Vita, including stairwells, corridors, recreation facilities, courtyard, parking garage, lobbies, and elevators. <u>It is also prohibited in Exclusive Use Common Areas, such as Unit balconies, patios, and roof decks</u>.

An additional note: if you smoke anything inside your unit that causes smells to exit into the hallways or other common areas and these smells become a nuisance to neighbors, you can be asked to install various odor mitigating devices.

**Common area gatherings** (barbecues, pool, and courtyard) are limited to <u>4 additional guests per unit (6 people total</u>). If you're planning a larger gathering you are required to notify the management office for specific details, and so that security can be made aware.

Barbecue area tables and chairs should not be moved, and residents should bring their own extras if needed.

**Vacation Rentals:** A Summertime reminder that the CC&Rs of la Vita do not permit vacation rentals FOR ALL OR PART of your unit for less than 30 days. This also includes during Comic-Con!

**OWNERS:** Please make sure your tenants are aware that they cannot sublet the unit, or any portion of a unit, at la Vita as a vacation rental. The OWNER will be responsible for any and all fines incurred by illegal vacation rentals. It is suggested that you build these requirements into your lease agreements.

Water from Patios and Balconies: We have had a recent uptick in complaints about water from balconies and decks intruding on units below.

Plants must have drip pans. When you water make sure drip pans do not overflow.

If you clean balconies, patios, or decks remember that any escaping water can directly impact lower units. Residents found allowing water to drip on lower units can be fined.

**Crows:** We have an influx of noisy, aggressive crows in the courtyard. Please do not feed the crows! They appear to be eating dog and cat food. If you have pet food bowls on the patios or balconies please bring them inside.

#### It's hard to turn off my shower, or it feels like I need just a little more "turn" to get enough hot water in my shower.

Never force your shower handle to shut off, or to get additional hot water! This is generally an indication that the shower cartridge needs to be replaced. Forcing the shower handle can cause the handle to break, potentially resulting in flooding.
